This agreement shall be held in force for the 2011-12 academic year, beginning August 1, 2011, and continuing as published in the Patten University Catalog.

### APPLICATION TIMELINE

The completed application package including official documents will be accepted until August 22nd for the Fall 2011 semester, January 9th for the Spring 2012 semester, and continuing according to the current published Patten University Catalog.

## TUITION AND FEES FINANCIAL AID

Patten will attempt to accommodate every transfer student according to the Award Letter and Financial Aid package awarded at Bethany. In order to make these accommodations, Bethany students transferring to Patten University are required to submit the following:

- Completion of 2011-12 FAFSA with Patten school code 004490
- Verification worksheet for independent or dependent students
- First 2 pages of parent's 2010 signed tax return
- Copies of all of parent's W-2 forms
- First 2 pages of student's 2010 signed tax return
- Copies of all of student's 2010 W-2 forms
- Copy of the student's 2011-12 Financial Aid Award letter or copy of the 2010-11 Award letter if the 2011-12 letter has not been issued.

Transfer students and first time Freshmen, will qualify for a continuous \$500 transition scholarship. Furthermore, Ministerial and Educator's dependents will be eligible for a \$1000 annual scholarship. The transferring students will receive an academic scholarship award package, equal to the award on record as documented by Bethany University.

Student athletes currently receiving an athletic award grant, will be awarded a like grant as part of their financial aid package, based upon timely consultation with the Patten Director of Athletics.

Transfer can be made based on existing 2+2 or 3+1 policies. 2. We will work with individual students to match their completed transfer courses with the appropriate Patten B.A. program. The intent of this work will be to determine best fit and keeping students on schedule for completion using both courses transferred into the Patten program in lieu of most appropriate Patten courses and other courses applied as minor/electives section of the degree programs. 3. In situations that involve a senior with less than 30 units remaining in their degree program, we can work with individual cases to council the student as to best fit.
